

MINUTES OF THE ECCLESIASTICAL ASSEMBLY HELD AT ST MARY'S PARISH HALL On 23rd May 2019 at 8.00pm

An Assembly of the Principals and Electors of the Parish of St Mary was held at the Parish Hall on Thursday 23rd May 2019 at 8.00pm to conduct the following business:

- Receive and if approved, adopt the Minutes of the previous Ecclesiastical Assembly held on Thursday 18th April 2019
- 2. Approve, if deemed advisable, the Churchwardens' Accounts for the year 2018-2019, previously examined by the Committee appointed for the purpose.
- 3. Elect Church Officers for the year 2019-2020
- 4. Elect a Committee to examine the Churchwardens' Accounts for the financial year 2019-2020
- 5. Conduct the sale of Froments

The Rector, Reverend Canon Tim Neill and welcomed everyone. Apologies were received from the following:

The meeting was attended by 19 people who were eligible to vote.

The Parish Secretary read the Convening Notice for the Assembly.

- The Minutes of the previous Ecclesiastical Assembly of Principals and Electors of the Parish of St Mary held on 18th April 2019 were adopted and signed following a proposal by Ann Watson (AW) and seconded by Daniel McCann (DM).
- 2. The Rector (TN) invited Frank Wood (FW) to present the Churchwardens' Accounts to the assembly. Two accounts were presented:

• Parish of St Mary Tresor Account

FW advised this account was funded by the Parish of St Mary. The 2 main expenditure items for 2018 were the repair of the organ and the service of the fire extinguishers. The other large expenditure was the church electricity (£3000) which included the months from November 2018 to January 2019.

Parish of St Mary Don Gruchy Account
 FW advised that a sum of £1000 was given to St Mary's Primary School for
 distribution by the Headteacher for the welfare of pupils as she sees fit. FW
 also advised that the Committee are actively looking at reducing the balance of
 this account. The Dean of Jersey has advised that the Committee can broaden
 the catchment for those that seek this funding. An example would be assisting
 families travelling to Southampton with sick children.
 There were no questions from the assembly.

Approval of both these accounts was proposed by David Munns and seconded by Daniel McCann.

The following accounts were not presented at this Assembly:

- Charity Account
- Don de Faye Account

As no Procureurs du Bien Publique were present the books were not signed. FW to request this is done at a later date.
