

MINUTES OF THE PARISH ASSEMBLY HELD AT ST MARY'S PARISH HALL ON THURSDAY 5th DECEMBER 2019 AT 8PM

An Assembly of the Principals and Electors of the Parish of St Mary was held at the Parish Hall on Thursday 5th December 2019 at 8pm to conduct the following business:

1. To receive and, if deemed advisable, approve the Minutes of the Parish Assembly held on Thursday 7th November 2019.

2. To elect three Roads Committee members to fill vacancies on the Comité des Chemins due to arise on 1st January 2020 for a term of three years.

3. To elect two Inspecteurs des Chemins for Vingtaine du Nord to fill vacancies arising on 1st January 2020 for a term of three years.

4. To elect two Inspecteurs des Chemins for Vingtaine du Sud to fill vacancies arising on 1st January 2020 for three years.

5. To elect two Rates Assessors for vacancies on the Experts Comité arising on 1st January 2020 for three years.

Apologies were received from John Alcock, Marilyn Evans, Geoffrey Grime, Ivor Barette, John Whitford, Edwin & Joan Godel.

The meeting was attended by 24 people who were eligible to vote.

The Secretary read the convening Notice for the Assembly and it was duly signed by the Connétable.

Item 1 – To receive and, if deemed advisable, approve the Minutes of the Parish Assembly held on $7^{\rm th}$ November 2019

The Connétable advised that copies of these Minutes had been circulated to the Assembly for approval. There being no matters arising, Deputy David Johnson proposed the adoption of the Minutes and they were seconded by Mark Evans.

Item 2 - To elect three Roads Committee members to fill vacancies on the Comité des Chemins due to arise on 1st January 2020 for a term of three years

The Connétable advised the Assembly that the current committee have expressed an interest in serving another 3 year term of office. The Connétable thanked them for their commitment for this current term. Peter Le Liard queried the length of term of office as it currently states 2 years on the Parish Assembly Notice. The Connétable agreed this was an error and it should read 3 years. The Notice is to be amended to reflect this correction. As there were no other nominations, the Connétable requested a proposer to re-elect the current members en-bloc — they being Martin Stodart, Trevor Le Sage and Peter Le Liard. The proposer was Jim Drew and the seconder Deputy David Johnson. The Connétable warned the newly elected members to appear at the Royal Court on Friday 13th December 2019 to be sworn in. A round of applause was then given to the newly elected committee.

Item 3 - To elect two Inspecteurs des Chemins for Vingtaine du Nord to fill vacancies arising on 1st January 2020 for a term of three years

The Connétable advised the Assembly that both Marilyn Evans and Emile Drean have indicated they wish to serve another term of office as Roads Inspectors for the Vingtaine du Nord. The Connétable thanked them for their service to the Parish and

requested a proposer for the re-election en bloc of these named Inspectors. The proposer was Daniel Reid and the seconder was Anne Proffitt. There being no other nominations, the Connétable declared Marilyn Evans and Emile Drean duly elected, thanked them for their further term of office and warned them to appear at the Royal Court at 10am on Friday 13th December to be sworn in.

Item 4 - To elect two Inspecteurs des Chemins for Vingtaine du Sud to fill vacancies arising on 1st January 2020 for a term of three years

The Connétable advised the Assembly that both Ivor Barette and Alan Moullin have indicated they wish to serve another term of office as Roads Inspectors for the Vingtaine du Sud. The Connétable thanked them for their service to the Parish and requested a proposer for the re-election en bloc of these named Inspectors. The proposer was Peter Le Liard and the seconder was Alan Le Breton. There being no other nominations, the Connétable declared Ivor Barette and Alan Moullin duly elected, thanked them for their further term of office and warned them to appear at the Royal Court at 10am on Friday 13th December to be sworn in.

Item 5 - To elect two Rates Assessors for vacancies on the Experts Comité arising on 1st January 2020 for three years.

The Connétable advised the Assembly that both Tony Gilbert and David Munns have indicated they wish to serve another term of office as Rates Assessors. He stated that the work of the Rates Assessors goes greatly unseen and he was glad of their expertise in this role. The Connétable requested a proposer for the re-election en bloc of both Tony Gilbert and David Munns. The proposer was Glynn Bower and the seconder was Mick Rondel. There being no other nominations, the Connétable declared Tony Gilbert and David Munns duly elected, thanked them for their further term of office and warned them to appear at the Royal Court at 10am on Friday 13th December to be sworn in.

The Connétable advised the Assembly that following the closure of this meeting a Vin D'Honneur would follow for retiring Vingtainer Michael Rondel.

The Assembly closed at 8.16pm.
