### PARISH ASSEMBLY

Notice is hereby given that an Assembly of the Principals and Electors of the Parish of St Mary will be held at St Mary's Parish Hall on **Thursday 15<sup>th</sup> December 2022 at 7.30pm** to conduct the following business:

1. To receive and, if deemed advisable, approve the Minutes of the Parish Assembly held on Thursday 18<sup>th</sup> August 2022
2. To appoint Roads Committee members to fill vacancies on the Comité des Chemins due to arise on 1<sup>st</sup> January 2023 for a term of three years.
3. To appoint Roads Inspecteurs des Chemins for Vingtaine du Nord and Vingtaine du Sud to fill vacancies arising on 1<sup>st</sup> January 2023 for a term of three years.
4. In Accordance with Article 32 of the Rates (Jersey) Law, 2005, to appoint Rates Assessors for vacancies on the Rates Assessment Committee arising on 1<sup>st</sup> January 2023 for three years.
5. Any Other Business

The Connétable, David Johnson, opened the meeting by welcoming everyone, and the Parish Secretary read the notice convening the meeting.

The meeting was attended by 15 people who were eligible to vote. Apologies were given by Frank Wood, Ann Watson, Martin de Gruchy and Jeremy Holmes.

- 1. To receive and, if deemed advisable, approve the Minutes of the Parish Assembly held on Thursday 18<sup>th</sup> August 2022**

The Connétable asked the Assembly for approval of the Minutes that had been made available. He also proposed that the discussion regarding the minutes would also be re-addressed in the next Rates Assembly as well as being approved at this assembly.

Minutes were approved by John Alcock and seconded by Peter le Liard. The Assembly agreed showing six voting hands for the approval of Minutes and none against.

- 2. To appoint Roads Committee members to fill vacancies on the Comité des Chemins due to arise on 1<sup>st</sup> January 2023 for a term of three years.**

The Connétable took the time to thank and appreciate all involved on the Comité des Chemin that have served the Parish to date and the amount of work that they undertake.

It was noted that there are three vacancies to be filled, two members have agreed to re stand for election and one other position to be elected for as a result of the retirement of Martin Stodart. The Connétable took the time to thank Martin for his continuous service as a member of the Comité des Chemin since 2011 and prior to that as a Rates Assess for at least 14 years.

Martin Stodart proposed both Peter Le Liard and Trevor le Sage for two appointments. Anne Proffitt seconded the motion. Martin publicly thanked both Peter Le Liard and Trevor le Sage for their work and noted their value on the Comité de Chemins.

Martin Stodart proposed Alan Moullin as a new member of the Comité des Chemins. He commented that as the longest service current Inspecteurs des Chemins he is well suited to stand as a member of the Comité. This nomination was seconded by Ivor Barette.

Alan stood to thank his proposer and seconder and publicly thank Martin Stodart for his service to the Parish.

A unanimous vote was taken for the positions of Comité de Chemins.

### **3. To appoint Roads Inspecteurs des Chemins for Vingtaine du Nord and Vingtaine du Sud to fill vacancies arising on 1<sup>st</sup> January 2023 for a term of three years.**

Two positions as Inspecteurs de Chemins du Sud and two as Inspecteurs du Nord have arisen.

Emilie Drean nominated Adrian de Gruchy as Inspecteurs des Chemins du Nord, noting that he has previously served the Parish as a member of the Honorary Police. Alan Moullin seconded Emilie's proposal. A unanimous vote was given.

Emilie Drean agreed to re-stand an Inspecteurs des Chemins du Nord. Alan Moullin proposed this, and Adrian de Gruchy seconded the proposal. A unanimous vote was given.

Ivor Barette agreed to re-stand as Inspecteurs des Chemins du Sud. Anne Proffitt proposed this, and Martin Stodart seconded the proposal. A unanimous vote was given.

In his absence Jeremy Holmes, a former Chef de Police of St. Mary, was proposed as Inspecteurs des Chemins du Sud by Ivor Barette. Sue Heppolette seconded this proposal. A unanimous vote was given.

Public thanks were given by the Connétable for the continued work by both Emile Drean, Ivor Barette, Martin Stodart and Alan Moullin for their work and support of the Parish

**4. In Accordance with Article 32 of the Rates (Jersey) Law, 2005, to appoint Rates Assessors for vacancies on the Rates Assessment Committee arising on 1<sup>st</sup> January 2023 for three years.**

Two of the present Rates Assessors terms have come to an end, both Cynthia Cotillard and Les Stanton have expressed their willingness to continue in these positions.


Anne Proffitt proposed both Cynthia Cotillard and Les Stanton for re-election and Adrian de Gruchy seconded the proposal.

The Connétable concluded that the swearing in date for the above elected candidates must attend The Royal Court to be sworn in on Friday 6<sup>th</sup> January 2023 at 10am

The meeting was declared closed by the Connétable at 7.44pm.
