### **MINUTES OF THE PARISH ASSEMBLY HELD AT ST MARY'S PARISH HALL On Tuesday 13th June 2023 at 7pm**

An Assembly of the Principals and Electors of the Parish of St Mary was held at the Parish Hall on Tuesday 13th June 2023 at 7pm to conduct the following business:

1. To receive and, if deemed advisable, approve the Minutes of the Parish Assembly held on Thursday 9th February 2023.
2. In Accordance with Article 32 of the Rates (Jersey) Law, 2005, to appoint two members of the Rates Assessment Committee with immediate effect and for a period of three years.
3. Approve updated Regulations for the New Cemetery.

The Connétable, David Johnson, opened the meeting by welcoming everyone. The Connétable asked if the Notice convening the Meeting could be taken as read to which the assent of the Meeting was forthcoming.

The meeting was attended by 10 people who were eligible to vote. Apologies were received from Sallie Redman and Jeremy Holmes and Recteur Kirsty Allan.

#### **1. Approval of Minutes**

The adoption of the Minutes of the Parish Assembly held on Thursday 9th February 2023 was proposed by Mr Terry Renouf and seconded by Mr David Munns and was duly approved by the Meeting. There were no matters arising.

#### **2. Appointment of members of the Rates Assessment Committee**

The terms of two members of the Rates Assessment Committee, Mr David Munns and Mr Tony Gilbert, had expired at the end of December last year. Mr Martin Stodart and Mrs Shirley de Gruchy had kindly agreed to stand for the vacant positions and were proposed and seconded as follows:

These appointments were approved by the Meeting and Mr Stodart and Mrs de Gruchy were therefore duly elected. They were warned to attend at the Royal Court on Friday 23rd June at 10am in order swear the oath of office.



**3. Approve updated Regulations for the New Cemetery.**

The Regulations for the New Cemetery had recently been reviewed and updated by the New Cemetery Committee. The draft amended Regulations had been posted on the Parish Website and printed copies had been made available from the Parish Hall. The Connétable briefly reviewed the proposed changes.

The adoption of the revised Regulations was proposed by Mr David Munns and seconded by Mr Martin Stodart and duly approved by the Meeting.

The formal business of the Assembly having been dealt with, the Connétable closed the Meeting at 7.20pm.
