

## Paroisse de Ste. Marie PARISH ASSEMBLY at St Marys Parish Hall on Friday 30<sup>th</sup> August 2024 at 7pm.

Minutes of an Assembly of the Principals and Electors of the Parish of St Mary held at St Mary's Parish Hall on Friday 30<sup>th</sup> August 2024 at 7 pm.

## WELCOME

The Connétable, David Johnson, opened the meeting by welcoming all present. The notice convening the meeting was taken as read. The meeting was attended by 9 parishioners who were eligible to vote.

## 1. Approval of Minutes

The Minutes of the Parish Assembly held on 20th June, 2024 had been made available at the Parish Hall, on the Parish website and also to parishioners attending the Meeting. They were duly approved following a proposition by Mr J Alcock, seconded by David Munns.

## 2. Consider Licensing Application – Mr Peter Tarrant

An application for a Third Category (Restaurant) Licence had been made relating to the operation of a catering van "The Ugly Oyster" located at The Seaside Cafe at Greve de Lecq. Under the provisions of the Licensing Law (Jersey) 1974, parishioners were required to consider such applications and to make a recommendation to the Licensing Assembly as to whether or not the application should be granted

Mr Tarrant addressed the meeting and gave a brief resumé of his operation at Greve de Lecq. The reason for the application was to enable alcoholic drinks to be served to diners seated in the alfresco seating area adjacent to his catering van.

The Connétable advised that all the requisite paperwork had been provided and that the application appeared to be in order from an administrative perspective. He had also interviewed Mr Tarrant.

It was therefore proposed that the Parish should recommend Mr Tarrant's application to the Licensing Assembly for approval. The proposition was put by Mr Jim Drew, seconded by Mr Daniel McCann and approved by the Assembly.

The Connétable advised that Mr Tarrant's original intention had been for the application to be made in the name of La Crete Seafood Ltd, of which Mr Tarrant was a director. In an exchange of correspondence with the licensing administrators and

with the agreement of the Bailiff's Chambers, it had been agreed that the application could be presented to the Licensing Assembly in the name of La Crete Seafood Ltd. This would be subject to the Parish putting out a notice to that effect, to give parishioners the opportunity to object prior to the Licensing Assembly. Any such objection should be raised with the Parish and the Judicial Greffe by 20<sup>th</sup> September, 2024.

The Connétable advised Mr Tarrant to appear before the Licensing Assembly in the Royal Court at 10am Thursday 26<sup>th</sup> September 2024.

The Connétable declared the meeting closed at 7.15p.m
