Minutes of an Assembly of the Principals and Electors of the parish of St Mary held at St Mary's Parish Hall on Monday 15th December 2025 at 7.30pm.

WELCOME

The Connétable, David Johnson, opened the meeting by welcoming all present. The notice convening the meeting was taken as read. The meeting was attended by 21 persons who were eligible to vote.

1. Approval of Minutes

The Minutes of the Parish Assemblies held on 26 June, 2025 and 27th August 2025 had been made available at the Parish Hall, on the Parish website and also to those attending the Meeting. They were duly approved on a proposition by Mr M Stodart, seconded by Miss B De La Haye.

2. Appoint members of the Comité des Chemins for a term of three years to fill vacancies arising on 1st January 2026.

3. Appoint of Inspecteurs des Chemins for a term of three years to fill vacancies arising on 1st January 2026.

The appointment of those nominated as shown was duly approved on a show of hands.

4. Appoint two Rates Assessors for a term of three years to fill vacancies on the Rates Assessment Committee arising on 1st January 2026.

Mrs Cynthia Cotillard and Mr Les Stanton were for reappointed to the Rates Assessment Committee on a proposition put by Mrs R Stockton, seconded by Mr D Munns and approved on a show of hands.

5. Ratify the Appointment of Officers of the Youth and Community Centre.

The Youth and Community Centre had held its AGM on 25th September, 2025 and, as required by its constitution, the appointment of the officers of its committee was required to be ratified by a Parish Assembly. The appointments made were as follows:

- Mr David Johnson had been elected as Honorary Chair.
- Laura Hefford retained her position as Honorary Treasurer.
- Annie Le Voguer retained her position as Honorary Secretary

These appointments were ratified on a proposition put by Mr R Stockton, seconded by Mr D Munns and approved on a show of hands.

6. Receive the Accounts of the St Mary Youth & Community Centre.

The Youth & Community Centre's Accounts for the 8 months ended 31st December, 2024 had been published on the Centre's webpage and had been made available to those attending this meeting. The Centre's financial year-end had been changed to 31st December with the intention that the Accounts would be available to be presented at the annual Parish 'Rates' Assembly in future years.

CONCLUSION

In relation to the above appointments as Members of the Comite des Chemins, the Connétable advised that they marked the retirement of Peter Le Liard who had been on the Comite for a continuous period of 27 years since January 2009. However, it was noted that Peter first began his service to the Parish as long ago as June 1972 when he was appointed Constable's Officer in which role he served until 1983, this followed by successive appointments as Vingtenier (from 1983 until 1995) and then as Roads Inspector until 2009. Save for a 6 month interlude in 1995, Peter had therefore served the Parish in various capacities for an unbroken period of 53 years since his first appointment and the Connétable proposed a vote of thanks to him for his outstanding dedication to the Parish during this time and wished him a happy retirement.
